The value of one ECTS for all study levels is defined according to the following pattern:

yearly tuition fee 60 ECTS

Students who take exams from previous years in the next school year pay the fee according to the number of transferred ECTS.

The value of transferred ECTS from previous years of Bachelor studies for courses that the student has already attended is reduced by 20%.

Bachelor students who, after the end of the last exam period in the current school year, have only the defense of their final thesis left, are exempted from paying the fee for enrollment in the repeated year, if the final thesis defense is completed by 31.10. current year.

A student who has lost student status for at least one school year is released from the obligation to pay the unpaid amount of tuition fee for the school year in which he/she had student status and is not entitled to reduction in the value of transferred ECTS in the school year in which he/she regains student status.

Tuition fee for all years of the study program of Bachelor studies is paid in two installments, with the first installment being paid upon enrollment and the second after completing the first semester. The student can also pay the tuition fee in full amount at once.

A student who does not pay the tuition fee is not allowed to register for exams or take the remaining exams determined by the study program or defend the final thesis.

First-time-enrolled Master students who submit their Master theses until the end of current school year (30.09.) are exempted from paying the fee for transfer of ECTS for the Master thesis.

For Master students who have lost student status, once they regain their status, the tuition fee is reduced by the amount corresponding to the number of recognized ECTS.

Tuition fee for study program of Master studies is paid in two installments, with the first installment being paid upon enrollment and the second after completing the first semester. The student can also pay the tuition fee in full amount at once.

A student who does not pay the tuition fee is not allowed to register for exams or take the remaining exams determined by the study program or defend the Master thesis.

A student who withdraws from the Faculty has the right to a refund of the tuition fee if he/she submits the request before the beginning of the school year (01.10.), with the Faculty retaining the administrative costs of withdrawal.

A student who has paid the tuition after passing the entrance exam is eligible to the refund of the paid amount if he/she is unable to enroll at the Faculty due to rejection of his/her request for a visa by the authorities of the Republic of Serbia. The student is obliged to submit documentation confirming that the rejection of the request is not the result of his/her illegal actions or incompletely submitted documentation. The Faculty refunds the amount to the student's foreign bank account specified when sending the refund request, whereby the student receives the paid amount decreased by eventual transaction processing costs.
